New Examination Pattern and Promotion Policy (2025-26)

For classes Nursery to 12

Examination Pattern

• Scholastic Area:

Unit Tests:

- The academic session for classes Nursery to II has been divided into three units: Unit Test 1, Unit Test 2, and Unit Test 3. The syllabus for classes Nursery to II is separate for the three terms.
- Assessment at the Foundational stage is not to provide any grade and score for a child's performance but to
 understand the progress, learning outcomes, and competencies. Assessment of children on all the essential aspects of
 their growth and development will be compiled as a Holistic Progress card (HPC), which is more descriptive and
 analytical than merely numerical.
- For classes III to IX and XI, One Unit Test will be conducted before the Mid-term Exam, and One Unit Test will also be
 conducted before the Annual Exam. The assessment of the students will be based on the examination scheme
 prescribed by CBSE. The students will be assessed regularly throughout the year.

- Syllabus of III to V will be separate for both the terms. The Question Papers for the Mid Term Examinations
 will be set out of the syllabus of the First Term and the Annual Examination will be held from the syllabus of
 the second term only i.e. 50% of the syllabus in HALF-YEARLY EXAMINATION and 50% in the ANNUAL
 EXAMINATION.
- Annual Examination of classes VI & VII will be set of the whole syllabus including 30% of the MIDTERM
 Syllabus and classes VIII including 40% of the MIDTERM.
- Annual Examinations of classes IX & XI will be set of the whole syllabus, covered in the first term and second term.
- Notebook Assessment (Portfolio) would be assessed before the end of each term based on the following Parameters
 - A.) Regularity B.) Assignment Completion c.) Neatness and Upkeep of Notebook
- Subject Enrichment would be assessed before the end of each term which includes Worksheets, Map activity, Graphs, ASL, and Experiments.

Class -X &XIIth (Acc. to CBSE Board Exams)

- 1. Scholastic Area (Classes IX and X)
 - (i) Final result will comprise the marks (Board Exam for class X, 80 marks and Internal Assessment 20 marks)
 - (ii) Internal Assessment comprises of periodic test (10 marks) Notebooks maintenance(5 marks) and Enrichment activity(5 marks) out of which students need to secure 33% (7 marks)
- 2. Co-Scholastic Area:

- (i) Co-Scholastic Activities will be assessed on a 5-point grading scale by the concerned teacher framing effective tools for the same.
- (ii) Grading will not have any descriptive indicators and students will not be upgraded based on the Co-Scholastic
- (iii) Co-Scholastic area will cover Work Education/Pre Vocational education Art Education/Health and Physical Education.

GENERAL INSTRUCTIONS:

- 1. Weekly assessments for classes Nursery to II are held each Monday (or on another day in case Monday is a holiday) as mentioned in the Year planner.
- 2. If a student is absent for any assessment due to illness, a medical certificate should be submitted to the Class teacher on the same day. Absence due to any other reason will result in the student being given **ZERO** in the assessment.
- 3. No student will be allowed to go home early after the Monday weekly test or any Unit test.
- 4. Cheating or using unfair means during an assessment will lead to strict action by the school and cancellation of the paper, with zero marks awarded in that assessment.
- 5. It is mandatory for the parents to attend all the parent-teacher meetings during the session. They should meet all the teachers teaching their children.
- 6. 75% attendance through the session is mandatory for a student to be eligible to appear in the final examination.
